Dear Minister Vernile:

At the February 26, 2018 Regular Council Meeting, Stratford City Council adopted a resolution in support of the joint Federation of Ontario Public Libraries/Ontario Library Association document that was submitted to the government as part of the 2018 budget process as follows:

WHEREAS public libraries provide safe, inclusive and vibrant community spaces where everyone is welcome to learn, work, connect and have fun;

WHEREAS the Stratford Public Library engages with the community and contributes to a culture of social good by sharing knowledge and resources; and

WHEREAS the Stratford Public Library continues to manage public resources with the utmost care and are committed to the sustainability of their services;

THEREFORE BE IT RESOLVED that the City of Stratford urges the Province of Ontario to recognize the contribution of local libraries within their communities and to cease the 20 year budget freeze to local libraries in an acknowledgment to the services they offer to all residents; and

BE IT FURTHER RESOLVED that the City of Stratford urges the Province to reinstate adequate and appropriate funding for local libraries, increasing each year going forward in line with the consumer price index; and

BE IT FINALLY RESOLVED that a copy of this resolution be sent to the Minister of Tourism, Culture and Sport, to the Ontario Minister of Municipal Affairs, to the local MPP's, to the Association of Municipalities of Ontario, to the Ontario Library Association, to the Federation of Ontario Public Libraries and to local area municipalities.

We support the concerns expressed by our local libraries, the Federation of Ontario Public Libraries and the Ontario Library Association. The 20 year funding freeze has had a negative impact on one of the community's most respected, high impact, trusted and highly used services – our local library.
